PRESIDENT'S REPORT – RICHARD M. ENGLERT

Thank you Mr. Chairman.

Although I will cover several points, my report today will be brief.

An Historic Year

The academic year we concluded in May will no doubt go down in Temple University history. It was an amazing year for national recognition. It also illustrates quality of teaching and research at Temple.

In the last academic year:

- Hazim Hardeman, Rhodes Scholar
- Marcus Forst, Goldwater Scholar
- Two Temple professors, Jeremy Schipper and Mark Franko, won Guggenheim Fellowships
- Sara Goldrick-Rab won a prestigious Andrew Carnegie Fellowship
- 11 students and recent graduates have won Fulbrights

Just think about that for a moment. You have no doubt heard of some of these achievements before. But when you put all of them together, the message becomes clear: In all of my years at Temple University, we have never had so many impressive awards.

Now you understand why I say the last year was a historic one for Temple University. I know I speak for all of you when I say how incredibly proud we are of these remarkable students and faculty, and the way their work has raised Temple's profile around the nation.

Optimistic look forward

Also this afternoon, I would like to briefly look ahead at the fall admissions picture.

As you know, higher education nationally is undergoing a number of challenges. Here are just a few:

- New England and Mid-Atlantic States face declines of 5 percent or more in the coming decade in the number of students graduating from high schools.
- Student demographics also changing: tomorrow's students are more likely to come from lower-income and first-generation families.
- There are growing questions about the cost vs. value of a four-year education. In my view, too many schools have priced themselves out of the market.

In light of this, Temple has several strengths that will serve us well in the future:

- Our reputation for diversity is a core element of our student body.
- Temple's urban location continues to be seen as a positive, providing student with access to jobs, internships and unique learning opportunities.
- Temple is viewed as an affordable alternative to many privates.

With all of that in mind, I want to give you a preview of our current admissions position. I am always cautious about quoting admissions figures before we go through the "summer melt" period, but I have to say I am very encouraged by the early trends. We have held to a strong position in the number and quality of applicants. In many areas, we have met or exceeded the records set in the last three years.

For example, GPA and SAT scores meet or exceed last year's numbers. And the diversity of our applicant pool continues at a level that is the envy of universities throughout the region and the nation. The only point of decline is the same area that has seen a drop at nearly every major university in the nation: international applications.

Temple's "You are Welcome Here" campaign has been designed to let students from other countries know that Temple University is open and happy to be their home for a high quality education.

I believe this effort will help undercut the concerns being expressed by students coming from abroad. Overall, the bottom line for admissions is this: While other institutions of higher education are struggling to fill their classes, Temple's growing national reputation continues to draw an applicant pool that is both high quality and diverse.

I will have a more detailed report on our admissions situation when we convene in the fall.

Conclusion

I would like to conclude by looking at some recent history. In the last several weeks, we have made some difficult decisions at Temple University.

Your vote on the Temple University Health System's future was not easy, but it was necessary. The leadership and staff at Temple University Health has pulled together to meet the challenges that lie ahead. I commend them for their dedication.

Likewise, the actions we are taking regarding the Fox School of Business are painful, but absolutely essential to the integrity and reputation of one of this nation's finest business schools.

I want to publicly thank all of you on the board of trustees for your insight and support as we move through these issues. Few people know how many hours trustees devote to these topics. Through it all, you have remained dedicated to one goal: Making the best choices for the students of this University.

I started my summary today talking about the extraordinary achievements that produced a record-breaking year.

It is the leadership and support of this board that has helped create that historic year and positioning us for another remarkable year ahead.

Good Afternoon Chairman O'Connor, President Englert, Board of Trustees and guests. I wanted to take this time to share with you some of the initiatives our administration has for the upcoming academic year. Since we were inaugurated April 30, Temple Student Government has officially welcomed a new team. Our administration ran under the ticket of Ignite TU with a platform that is built on the foundation of three pillars: Enhance, Amplify, and Empower.
