U.S. FULBRIGHT STUDENT GRANTS

- Administered by the U.S. Department of State.
- Largest U.S. exchange program, awarding approximately 1,500 grants each year to recent bachelor's degree recipients, master's and PhD candidates.
- Support international research, English teaching assistantships and cultural exchange.
- In the last 20 years, Temple University students have received 47 U.S. Student Fulbright Awards.
 - Over that period, Temple's success rate of applicants who ultimately receive the award is 30 percent.
 - National average is 22 percent.
 - Five students received the award last year alone.

 - Out of 15 applications this year, we know that four students have advanced to second round of competition.
