PRESIDENT'S REPORT - NEIL D. THEOBALD

"Thank you, Mr. Chairman.

"Since I arrived at Temple two and a half years ago, one of my primary goals has been to create greater pride in this institution, to help others see what I see. I have wanted people to know that this university offers one of the best student learning experiences in the world.

"Recently, we have formed several partnerships with other institutions around the world. What's happening here is simple: Temple's growing reputation is drawing other schools to seek us out and propose new relationships that benefit our students and theirs. Let me start with our recent trip to Asia.

"In China, we signed Memoranda of Understanding with South University of Science and Technology and Zhejiang University. We also entered an agreement for a dual bachelor's-master's degree program with Kookmin University in South Korea. These are some of the premier institutions in their countries and they add to the impressive list of partnerships we have formed throughout Asia.

"Temple has been known for its presence in Japan and Rome for decades, but today we can truly say that Temple has become a force in global higher education. Thanks to the visionary leadership of this Board, and the investment you've made in our growth, Temple is a place with whom other universities want to partner.

"I want to thank Trustee Lonnie Moulder, who joined us for part of the trip and delivered the Commencement Address at our Tokyo campus. Lonnie, I much appreciate your willingness to use your time and talents to benefit Temple.

"I was also joined on the trip by Ken Lawrence, our new Vice President for Alumni Relations, Jim Dicker, our Vice President for Institutional Advancement, and Hai-Lung Dai, our Provost and Senior Vice President for Academic Affairs. I give my thanks to them all.

"During the time we spent in China, Japan and South Korea, we met with higher education leaders, spoke with alumni and supporters, and laid the groundwork for Temple's continued success in that important part of the world. Let me give you just one indicator of Temple's influence there. We now have about 1,000 Temple alumni in Korea. More than 100 of them came to our alumni event last month. More than 10 percent of all Korean alumni of Temple were in attendance. I was astounded by their love for Temple and the pride our Korean alumni showed during this visit. Temple University's reputation and influence continue to grow and thrive in Korea, Japan and China, and we have only begun to reap the benefits of these important new relationships.

"Our outreach to partner universities and our increased alumni engagement are not limited to Asia. Here in the United States, Temple has joined a national research consortium aimed at measuring and improving the success of our graduates. We are part of an ongoing research project organized by The Gallup Organization to identify the determinants of our graduates' long-term success in pursuing great jobs and great lives. This effort includes surveys asking our graduates about their engagement with work, their overall life evaluation and well-being, and what factors in their experience at Temple were most important in their later lives. This is vital information. It will allow us to measure the value of a Temple education beyond the traditional measures of salary in the first job or percentage of students attending graduate school the year after they graduate. Instead, we will be able to focus on what matters more. The fact is this: The value of a college education is best measured as a long-term investment, rather than a quick payback scheme.

"With this survey, Temple is taking an important step to measure the impact of that investment and what specific experiences contribute to a successful college experience to ensure that our current students have access to what is most important in allowing them to excel in their careers and in their lives. Critically, the data we receive from this project will allow us to compare ourselves against other top universities and a national benchmark.

"The members of the consortium are impressive. They include Purdue University, the University of Pittsburgh, Virginia Tech, the University of Virginia, and George Washington University. The first alumni surveys are scheduled to go out in August. I look forward to sharing the results with you this fall.

"Before I go, I want to tell you about a few more ways we are stepping up our efforts to engage our alumni and encourage them to come back and see firsthand the transformation of their alma mater.

"For this fall, we are already planning for Alumni Weekend and a parents' weekend, among other events. We are also preparing several activities leading up to our first football game against Penn State on September 5. Athletics are a major touch point for alumni. They are important not just for the games themselves, but for the opportunities they present. The football experience brings us together as a community and builds bonds between our alumni and students. In a football season marked by home games against Penn State and Notre Dame, we plan to capitalize on every opportunity to bring the Temple community together. The game day experience is one of the few university events where we reach out to alumni, students, faculty, staff, parents and friends and invite them to celebrate together. I know you join me in looking forward to the exciting game day opportunities this season and in the future.

"I also want to thank this Board for its outstanding leadership. Your investment in Temple is the reason we're reaching these new heights. I especially want to thank Trustee Scott Cooper, who, in his role as leader of the Temple University Alumni Association, is bringing new energy to our engagement with alumni everywhere.

"I look forward to celebrating the start of an exciting school year with you in about six weeks. Thank you."

"Chairman O'Connor, President Theobald, and Members of the Board of Trustees, thank you for the opportunity to share with you our work this summer. Very briefly, the Faculty Senate has been working in committees this summer on three issues:

- "1. **REVISION OF THE FACULTY HANDBOOK**: One of our most essential tasks this summer and through next year is the revision of the Faculty Handbook that serves as the policy document for all Temple University. It is especially important for faculty in non-TAUP units. The Handbook is in need of updating to reflect recent changes in the TAUP Contract and Temple Policies. We plan to work with Temple Administration, specifically Vice Provost for Faculty Affairs Kevin Delaney and Director of Human Resources Sharon Boyle to make sure the Handbook revisions are aligned with other governing documents.
- "2. <u>TUITION BENEFITS EXPLORATION</u>: The Faculty Senate is working with TAUP on the side bar issue of exploring possible tuition benefits for Temple Faculty. In last fall's contract negotiation, the following sidebar was included:

Side Letter - Tuition Benefits at other colleges/universities. The University understands that TAUP and the Faculty Senate may work to formulate proposals for tuition benefits for children of bargaining unit members who attend other colleges and universities. The University shall review, consider and respond to any proposals in a timely fashion.

"A faculty committee headed by Professor Heather Porter has been researching tuition benefits options and has developed a survey to ascertain the level of faculty interest in various options. Data from the survey will be shared with Administration and will be used in the development of recommendations this fall.

"3. EXPLORATION OF ALTERNATIVE DISPUTE RESOLUTION PROCESSES FOR FACULTY IN NON-UNION RELATED DISPUTES: Many institutions of higher education, like other private and public sector organizations, have internal dispute resolution processes that complement existing union grievance procedures. These ADR processes are valuable for addressing non-union related disputes in a preventative and interest-based manner. The Faculty Senate is reviewing best practice models in higher education to present to the Vice Provost for Faculty Affairs and the Provost's Office in fall 2015.
